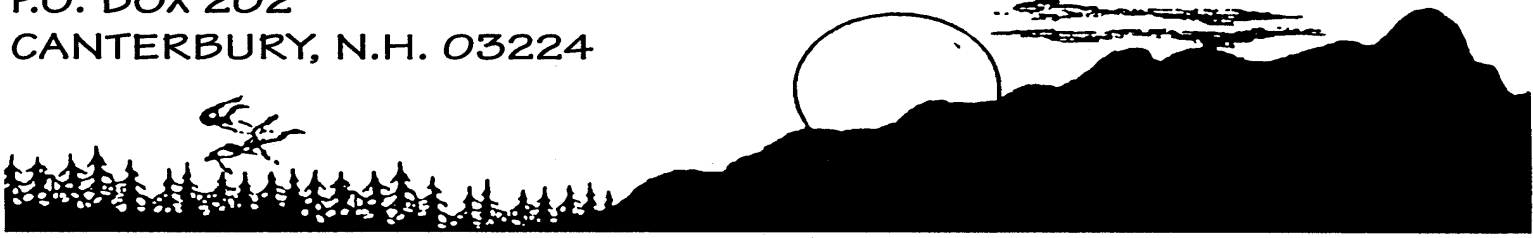

As a shooting club, we cannot afford any amount of carelessness, ignorance of the rules, or vandalism among our members or guests. The consequence could be closure of the club. As the club moves forward proactively we have implemented more precautionary safety measures, and will soon install modernized security measures.

## Pledge of Acceptance

I pledge my acceptance of the Range and Safety Rules of Sunset Mountain Fish & Game Club. These rules are found on the club website or are available in printed form from an officer of the club. I have, or will read and follow all rules found in the Range and Safety Orientation for New Members (rev. 5-31-2005). In addition, I agree to the following:

- I will never have my finger on the trigger of a loaded firearm with its muzzle pointed above the berms or in an unsafe direction.
- I will ensure that target height is such that all shots fired will impact the berm.
- I understand that shooting at objects placed on the ground or on the tops of frame rails is strictly forbidden.
- I will never give permission in any way for unescorted non-members to use the club facilities.
- I understand I may be held accountable for my guests' actions.
- I will keep my membership card in plain view and present it to any member who asks to see it.
- I will report any incidents of safety violations, vandalism, or trespassing immediately to an officer of the club.
- I understand I can and will be expelled permanently from SMF&G Club if I exhibit negligence in regards to the safety rules of the club.

I understand a personal safety orientation will be arranged for me if I so desire.
